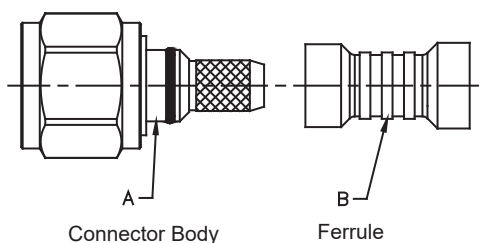

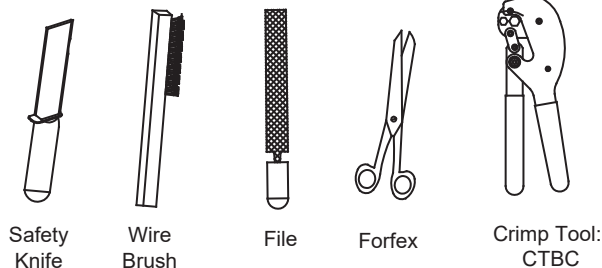

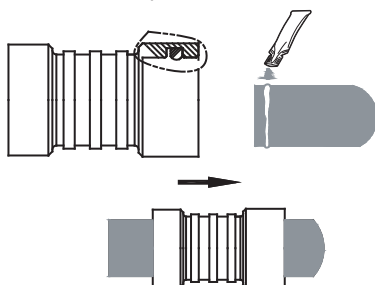
Tools



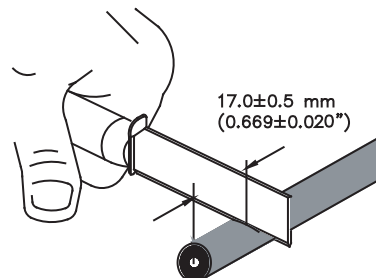
- 1.** Straighten the first 200.0 mm (7.874") of the cable.



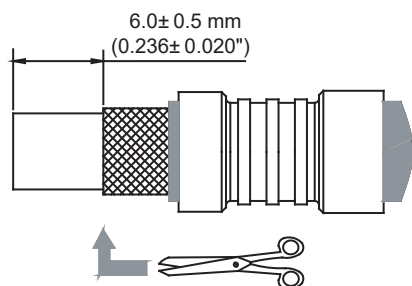
- 2.** Daub grease onto cable uniformly as shown; Slide part B onto cable as shown.



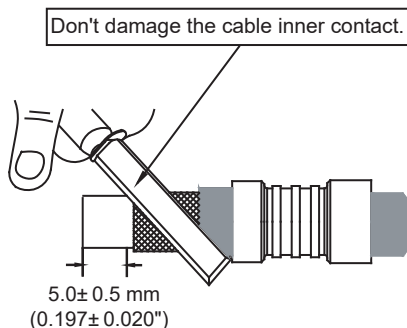
- 3.** Remove 17.0 mm (0.669") of Jacket only.



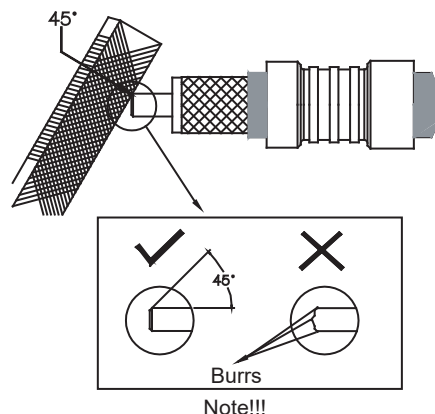
- 4.** Trim 6.0 mm (0.236") of braid, exposing foam.



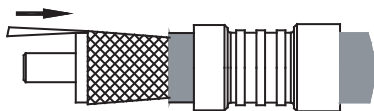
- 5.** Remove 5.0 mm (0.197") of foam, exposing center conductor.



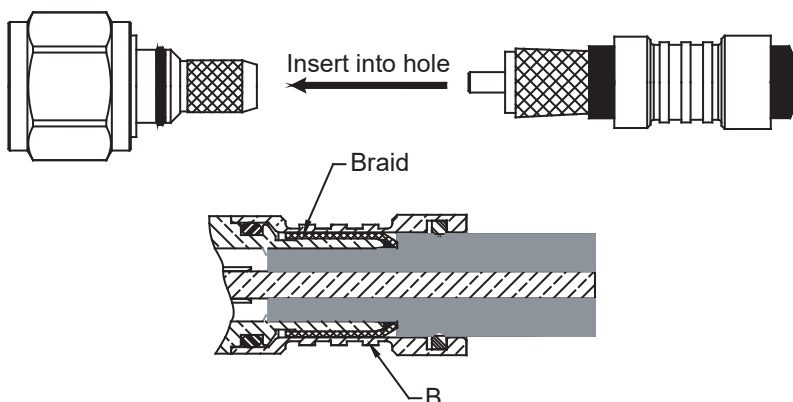
- 6.** Chamfer the center conductor at a 45° angle.



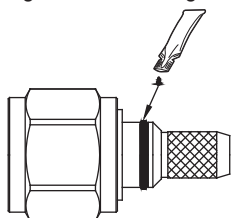
- 7.** Splay out braid as shown.



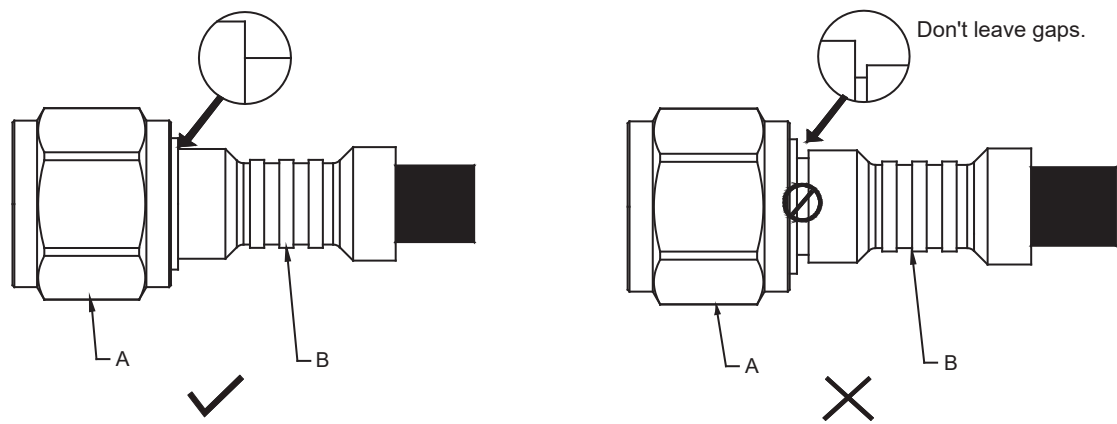
- 9.** The cable attachment must be straight and aligned with the hole of connector inner contact. Insert the cable attachment into connector body until stopped, the cable center conductor must be inserted into inner contact fingers. Make sure the braid cover the body sleeve, then twist part B until stopped.



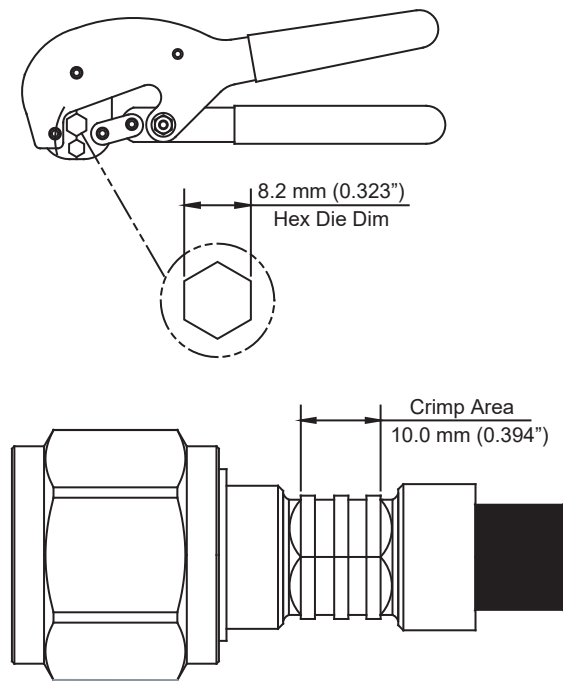
- 8.** Daub grease onto O ring circuit uniformly.



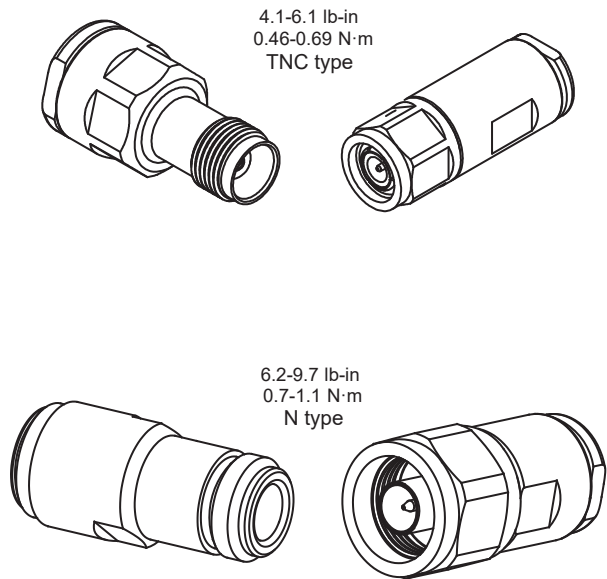
10. Part A and B status as shown.
